

# **\*\*\*NOTICE\*\*\***

**The following are not eligible for Deferred Disposition in the Justice of the Peace Precinct 2 Court:**

- 1. Speeding in excess of 24 mph above the posted speed limit on a highway;**
- 2. Speeding in excess of 9 mph above the posted speed limit in a residential area;**
- 3. Speeds of 85 mph or higher;**
- 4. If you have taken a driving safety course in the preceding 12 months to dismiss a ticket;**
- 5. If you have two or more traffic violations, within the last three years, listed on your driving record;**

**If your request is denied, you will be convicted and have 10 days to pay the fine, complete a payment plan or appeal. The fine will be the same as if you paid it at the window.**

**The Deferred Disposition expense for all traffic violations is \$301.00 and must be paid within 30 days of your request.**

**I swear the following statements are true and correct:**

1. I am over the age of 17 years,
2. I waive my right to a trial and I enter a plea of No Contest;
3. Within the last 3 years:  
 I have not received Deferred Disposition for a traffic violation in another Justice or Municipal Court.  
 I have received Deferred Disposition for a traffic violation in another Justice or Municipal Court. Give name of court(s)/Date(s) \_\_\_\_\_
4. I have **NOT** taken a Driving Safety Course in the past 12 months to dismiss a traffic violation. **IF YOU HAVE, YOU ARE NOT ELIGIBLE FOR DEFERRED DISPOSITION IN THE JP2 COURT.**
5. I am not indigent and can pay the **\$301.00** Deferred Disposition fee within 30 days.
6. I hold a valid Texas Driver's License. **I do not hold a Commercial Driver License.** I am providing the court with a photocopy of **BOTH** my valid Texas driver's license or permit and proof of financial responsibility that is valid as of the date of this request;
7. **I UNDERSTAND I WILL BE ON PROBATION FOR A MINIMUM OF 90 DAYS (3 MONTHS) IF I AM GRANTED DEFERRED DISPOSITION. IF I AM CONVICTED OF ANOTHER TRAFFIC OFFENSE DURING THIS TIME, I WILL BE CONVICTED OF THIS OFFENSE AS WELL. I UNDERSTAND I MUST RETURN AN AFFIDAVIT OF MY COMPLIANCE AT THE END OF MY PROBATIONARY PERIOD.**
8. **I UNDERSTAND THAT IF THE REQUIRED COSTS AND FEES ARE NOT RECEIVED BY THE COURT ON OR BEFORE 2:00 O'CLOCK P.M. ON THE DATE REQUIRED, I WILL BE CONVICTED AND A WARRANT MAY BE ISSUED FOR MY ARREST.**
9. **I UNDERSTAND THAT IF I AM UNDER THE AGE OF 25, BY LAW I WILL BE REQUIRED TO TAKE A DRIVING SAFETY COURSE TO RECEIVE DEFERRED DISPOSITION.**
10. **I UNDERSTAND THAT IF MY REQUEST IS DENIED, I WILL BE CONVICTED AND HAVE 10 DAYS TO PAY THE FINE, COMPLETE A PAYMENT PLAN OR APPEAL.**
