REMEMBER PEARL HARBOR

DECEMBER 7, 1941

USS Arizona Memorial



The final resting place for 1,102 (75 were recovered) crewmen of the U.S.S. Arizona who lost their lives on December 7, 1941. They are still entombed within the Arizona herself. [The sunken battleship](#) is commemorated by a 184 foot-long memorial structure that spans its mid-portion. No part of the edifice touches the ship.

There are three sections in the memorial: The [entry](#) and assembly room, [\(a central or middle area\)](#) used for observations of the sunken ship and for ceremonies. Many visitors drop flower leis into the water from this section, honoring the dead. The third section is the [shrine room](#). The room contains the names of all those killed on the Arizona and their names are engraved on a marble wall. Upon entering the shrine room, the reverence and honor it is was intended to inspire is immediately noticeable. All persons are keenly aware that this is hallowed ground.

The memorial's architect was Alfred Preis. After years of fund raising efforts that began 1950, the memorial finally was dedicated in 1962.

The USS Arizona is no longer in commission, contrary to popular belief. A flag of the United States of America does fly above the sunken battleship. The flag is attached to a severed mainmast of the USS Arizona.

In recent years, the memorial has come to represent all the military and associated personnel killed at Pearl Harbor.

Who is eligible for Military Funeral Honors?

- *Military members on active duty or in the Selected Reserve.*
- *Former military members who served on active duty and departed under conditions other than dishonorable.*
- *Former military members who completed at least one term of enlistment or period of initial obligated service in the Selected Reserve and departed under conditions other than dishonorable.*
- *Former military members discharged from the Selected Reserve due to a disability incurred or aggravated in the line of duty.*

Who is not eligible for Military Funeral Honors?

- *Any person separated from the Armed Forces under dishonorable conditions or whose character of service results in a bar to veteran's benefits.*
- *Any person who was ordered to report to an induction station, but was not actually inducted into military service.*
- *Any person discharged from the Selected Reserve prior to completing one term of enlistment or period of initial obligated service for reasons other than a disability incurred or aggravated in the line of duty.*
- *Any person convicted of a Federal or State capital crime sentenced to death or life imprisonment.*

What is Military Funeral Honors?

Military Funeral Honors have always been provided whenever possible. However, the law now mandates the rendering of Military Funeral Honors for an eligible veteran if requested by the family. As provided by law, an honor guard detail for the burial of an eligible veteran shall consist of not less than two members of the Armed Forces. One member of the detail shall be a representative of the parent Service of the deceased veteran. The honor detail will, at a minimum, perform a ceremony that includes the folding and presenting of the American flag to the next of kin and the playing of Taps. Taps will be played by a bugler, if available, or by electronic recording. Today, there are so few buglers available that the Military Services often cannot provide one.

How much does a Military Funeral Honors detail cost?

Military Funeral Honors are provided by the Department of Defense at no cost to the family.

How does a family request funeral honors?

Families of eligible veterans request funeral honors through their funeral director. The funeral director will contact the appropriate Military Service to arrange for the funeral honors detail.

What can the family of an eligible veteran expect?

The core elements of the funeral honors ceremony, which will be conducted on request, include:...

- *Flag folding*
- *Flag presentation*
- *Playing of Taps*

The veteran's parent Service representative will present the flag.

Korean War Medal of Honor Recipient

*Martinez, Benito

Rank: Corporal

Organization: U.S. Army, Company A, 27th Infantry Regiment, 25th Infantry Division.

Place and date: Near Satae-ri, Korea, Sept. 6, 1952.

Entered service at: Fort Hancock, Texas.

Birth: 1931, Fort Hancock, Texas.

General Order No.: 96, Dec. 29, 1953.

Citation: Corporal Benito Martinez, Infantry, United States Army a machine gunner with Company A, 27th Infantry Regiment, 25th Infantry Division,, distinguished himself by conspicuous gallantry and outstanding courage above and beyond the call of duty in action against the enemy near Satae-ri, Korea on 6 September 1952. While manning a listening post forward of the main line of resistance, his position was attacked by a hostile force of reinforced company strength. In the bitter fighting which ensued, the enemy infiltrated the defense perimeter and, realizing that encirclement was imminent, Corporal Martinez elected to remain at his post in an attempt to stem the onslaught. In a daring defense, he raked the attacking troops with crippling fire, inflicting numerous casualties. Although contacted by sound power phone several times, he insisted that no attempt be made to rescue him because of the danger involved. Soon thereafter, the hostile forces rushed the emplacement, forcing him to make a limited withdrawal with only an automatic rifle and pistol to defend himself. After a courageous six-hour stand and shortly before dawn, he called in for the last time, stating that the enemy was converging on his position His magnificent stand enabled friendly elements to reorganize, attack, and regain the key terrain. Corporal Martinez' incredible valor and supreme sacrifice reflect lasting glory upon himself and are in keeping with the honored traditions of the military service.



Korean War Tidbits

(E)isenhower -- In December 1950, as part of the great rearmament buildup in the wake of the Korean War, President Harry S. Truman appointed General Dwight D. Eisenhower To command the forces of the North Atlantic Treaty Organization (NATO). But in June 1952, the ever-popular "Ike" resigned from the Army and returned to the U.S. to run for president as a Republican. (page 103) (KW)

(F)ilm, television, and literature of the Korean War -- The Korean War was not covered directly by television, as was the war in Vietnam. In fact, the fledgling television networks did not even try in most cases to replace the official coverage provided by the government. Of course, newsreels of events were available on a delayed basis in the movie theaters, as was the Hollywood version of the war presented in Korean War combat films. (page 111) (KW)

WASHINGTON – Owning a franchise operation is now more affordable for veterans, thanks to a program recently announced by Secretary of Veterans Affairs Anthony J. Principi.

The Veterans Transition Franchise Initiative, commonly known as “VetFran,” allows veterans to acquire a franchise with a downpayment of 10 percent or less of the initial franchise cost, which generally ranges from \$45,000 to \$150,000 for a small business. Franchising companies absorb the difference. “Veterans are self-starters who possess an excellent work ethic. They are leaders who know how to manage others,” Principi said. “The VetFran program provides veterans who want to be in business for themselves a wonderful opportunity to get their feet in the door.”

Dr. Leo S. Mackay Jr., VA's Deputy Secretary, was the featured speaker at a Sept. 24 meeting of the International Franchise Association (IFA), VetFran's sponsor, to launch the new initiative.

Mackay also attended the annual convention in Orlando, Fla., earlier this year where the two organizations signed a Memorandum of Understanding (MOU) that they will work to promote franchise opportunities for veterans. IFA's Chairman Jim Amos, President/CEO of Mail Boxes Etc, Inc., joined him in signing the MOU.

“I am convinced that the partnership we are embarking on is a win-win collaboration. It represents confidence in our nation's veterans, benefits to our economy, and an investment in the future of America” said Mackay.

IFA first introduced VetFran in the early 1990s as a way for franchisers to express gratitude to military members for their service during the Gulf War. In the last several years, the program had all but been forgotten. The current war against terrorism has rekindled interest in extending franchise opportunities to military veterans.

A Hawaii veteran recently became the first to acquire a franchise under the revitalized VetFran program, obtaining a franchise for Expectec Technology Services, a technology supplier headquartered in Garden Grove, Calif. He paid \$40,000 instead of the \$60,000 he would have paid without VetFran.

Currently, VetFran is limited to franchises with initial investments up to \$150,000, the maximum loan amount on which the SBA offers 85 percent loan guarantees. So far, nearly 75 franchisers are participating. VetFran may expand later to include franchises costing over \$150,000, for which the SBA offers 75 percent loan guarantees. “When they one day put aside their uniforms, today's servicemen and women must know that they will have real means and opportunities to pursue a career, and make a living for themselves and their families,” said Mackay. “This initiative helps provide that.”
